MEDICAL RELEASE AND CONSENT FORM AGREEMENTS

1. First-Aid/Emergency Treatment Consent

Without limiting other emergency powers that may be provided by law, I authorize Vietnamese Youth Movement (aka TNTT-TDV) personnel to administer first-aid to my child if TNTT-TDV administration deems it necessary and appropriate to preserve the life, limb or well-being of my child. If TNTT-TDV administration believes, in its sole discretion, that a medical necessity exists beyond that which can reasonably be dealt with on church grounds by TNTT-TDV personnel, I authorize TNTT-TDV to contact and engage qualified medical personnel and arrange for emergency treatment of my child, including transportation either by TNTT-TDV leaders or by professional transport for medical, dental, surgical or hospital care or diagnosis, and I consent to that treatment for my child. Arrangements for treatment will be made in the following order of priority: 1) The "primary physician" indicated for the student(s); 2) another physician or health-care professional licensed by the State of California. I understand and agree that I will be financially responsible for any such medical treatment. In consideration of the arrangement indicated in this paragraph, I hereby release and discharge the Diocese of San Jose, its constituent organizations, including but not limited to Saint Elizabeth Catholic Church, Vietnamese Eucharistic Youth Movement, TNTT-TDV, and their officers, agents and employees (the "Diocese") for any and all claims for personal injuries or property damage that I or my child may suffer as a result of this arrangement whether or not such injuries or damages be caused by the negligence (whether active or passive) of any of the entities or individuals named or described above, excepting only injuries or damage resulting from Diocese's willful misconduct.

2. Release of Student to Qualified Emergency/Medical Personal and Third Parties

Without limiting other emergency powers as may be allowed by law, in the event of disaster or medical necessity involving the life, limb or well-being of my child in which it is necessary in the opinion of the TNTT-TDV administration to transport my child from church property, or if it is necessary to evacuate the church grounds, TNTT-TDV will make a reasonable effort (in view of the nature of the necessity) to first contact a parent or legal guardian. If no parent/legal guardian is available, I authorize TNTT-TDV to release my child into the custody of third parties for the purpose of transporting my child from church grounds and arranging for such care as my child may need, in the following order of priority: 1) the persons listed as emergency contacts; 2) qualified medical/emergency professionals; 3) another responsible adult.

3. Gathering, Use and Release of Medical Information

Without limiting other emergency powers that may be provided by law, in the event of disaster or medical emergency, I specifically authorize the gathering, use and release to, from, and among TNTT-TDV personnel and to, from and among any medical professionals, of any medical information reasonably necessary to provide emergency medical care and otherwise ensure the life, limb and well-being of my child, including without limitation, the information contained in this form, until I can reasonably be notified and take custody of my child. I understand that this information will be requested, gathered and/or released only for the purpose of providing first-aid or emergency medical care necessary in the absence of a parent or legal guardian, or as otherwise allowed by law.

4. Release of Voluntary Activities

As the parent/legal guardian, I authorize my child participate in the events and activities of the Vietnamese Youth Movement (aka TNTT-TDV) (hereinafter "Activity").

- a. I understand and acknowledge that this Activity may be dangerous and hazardous and, by its very nature pose the potential risk of severe and serious physical and emotional injury/illness, or even death, to all individuals who participate in such Activity.
- b. I understand and acknowledge that in order to participate in this Activity I agree to ASSUME ALL LIABILITY AND RESPONSIBILITY for any and all potential risks, injuries, or even death which may be

- associated with participation in such Activity. I represent and warrant that Student/Participant is mentally and physically fit, capable, able, and willing to participate in this Activity without any limitations.
- c. I understand, acknowledge, and agree that the TNTT-TDV, its trustees, employees, agents, coaches, teachers, volunteers, or representatives shall not be liable for any injury/illness suffered by Student/Participant which is incident to and/or associated with preparing for and/or participating in this Activity.
 - d. I hereby release, discharge, indemnify, and agree to hold harmless TNTT-TDV, TNTT-TDV's governing board ("Board"), and each of their trustees, employees, agents, coaches, teachers, volunteers, and representatives free from any and all liability arising out of or in connection with Student/Participant's participation in this Activity, including all related activity such as games, practices, training activities, trips and related exercise. For purpose of this RELEASE, liability means all claims, demands, losses, causes of action, suits, or judgments of any kind that Student/Participant or Student/Participant's parents, guardians, heirs, executors, administrators, and assigns may have against TNTT-TDV, Board, and their trustees, employees, agents, coaches, teachers, volunteers, and representatives because of Student/Participant's personal, physical or emotional, injury, accident, illness, or death, or because of any loss of or damage to property that occurs to Student/Participant or his or her property during Student/Participant's participation in the Activity that may result from any cause including but not limited to TNTT-TDV's, Board's, trustees', employees', agents', coaches', teachers', volunteers', or representatives' own passive or active negligence or other acts other than fraud, willful misconduct or violation of the law.

5. Release of Photo/Image and Personally Identifiable Information

As the parent/legal guardian, I grant permission to TNTT-TDV to use my child's photos/images that includes my child's name without any other personal identifiers to be published on the youth group's (TNTT-TDV) public Internet site or yearbook.

- a. As I am aware, there are potential dangers associated with the posting of personally identifiable information on a web site since global access to the Internet does not allow us to control who may access such information. These dangers have always existed; however, we as a youth group do want to celebrate your child and his/her work. The law requires that we ask for your permission to use information about your child.
- b. Pursuant to law, we will not release any personally identifiable information without prior written consent from you as parent or guardian. Personally identifiable information includes participant's names, photo or image, residential addresses, e-mail address, phone numbers and locations and times of class trips.
- c. If you, as the parent or guardian, wish to rescind this agreement, you may do so at any time in writing by sending a letter to the head coordinator of your child's youth group and such rescission will take effect upon receipt by the school.

I acknowledge that I have carefully read this MEDICAL RELEASE AND CONSENT FORM and that I understand and am fully aware of the legal consequences of this agreement, and agree to its terms.
